Overview

Inspiring Western Australia is offering **grants of up to \$10,000** to support community STEM (Science, Technology, Engineering & Maths) projects and events in Western Australia during National Science Week.

National Science Week is Australia's annual celebration of science, held in August. In 2026, it runs from 15 - 23 August, offering communities across the country the chance to take part in exciting science events and activities.

Your project should focus on eligible activities in August 2026 as part of National Science Week. Where possible, it should engage historically underrepresented groups in STEM or highlight the contributions of scientists from these communities, including:

- First Nations communities and projects that highlight First Nations contributions to STEM
- Regional and remote communities
- Women and girls (including projects that highlight their achievements in STEM)
- Culturally and Linguistically Diverse (CaLD) people
- People with disability
- Neurodivergent people
- People from low socio-economic backgrounds
- LGBTQIA+ people
- People facing age-based discrimination

To strengthen your application, clearly identify your target audience and how you will engage them. Ensure your project meets all essential criteria before proceeding.

Eligibility

To be eligible, your organisation must:

- Be a **registered organisation** (ABN or auspice required)
- Uphold the **National Principles for Child Safe Organisations**, comply with all relevant Western Australian child safety laws and provide documentation upon request.
- Engage an **underrepresented community group** in a STEM-based activity, as outlined above.
- Run your event during **August 2026**.
- **Not** run a **school-only** event*
- Provide a **clear budget that meets grant guidelines**.
- Collect participant feedback and meet reporting requirements**
- Have appropriate **insurance** coverage for your event

Your event should benefit the **wider community, not just school staff or students.*

*** Inspiring WA will provide participant feedback surveys and reporting templates. Not meeting reporting requirements may affect future funding eligibility.*

Application Questions

Applications that meet the eligibility criteria will be assessed through the following questions.

1. **Please describe your event.** *Include a brief overview, the timeline or schedule, key activities, and who will be involved.*
2. **Which historically underrepresented community in STEM will your event engage? How will you actively engage the selected community or communities in your event?** *This could include strategies such as partnering with community organisations, involving speakers or presenters from the community, or other meaningful participation.*
3. **Please attach a letter of support or other supporting documentation that demonstrates collaboration with, or engagement of, the identified community or communities.** *If your organisation represents the community being engaged, you may also provide documentation to showcase this.*
4. **What STEM (science, technology, engineering and mathematics) content will your project cover and how will this be delivered?**
5. **What do you want to achieve through this event and how will the community benefit?** *List the outcomes you're aiming for, such as increased STEM interest, skill development, or community engagement.*
6. **Detail your plan to promote the event to your target audience.**
7. **What challenges might arise, and what is your plan to manage them?** *This includes anything that may affect the event like poor weather, guest presenter cancellation, or a change in resources.*
8. **How will you track attendance and gather feedback from participants?**
9. **What experience, skills, and resources does your organisation have to make this event a success?**
10. **How will your project create future STEM opportunities or have a lasting impact beyond the event?** *Please describe the potential impact on your organisation, partner organisations, or participants.*
11. **How will your project minimise environmental impact?**
12. **How much will this event cost participants? Include the amount and the reason for the cost?**

Budget Guidelines

You can apply for **\$5,000 - \$10,000 (excluding GST)** to cover costs like:

- Promotional materials (e.g. posters, radio advertisements, social media ads, photography).
- Accessibility services or practitioners (e.g. Auslan translators).
- Catering (a suggested 15% of budget towards catering)*
- Project officer salaries or wages (a suggested 20% of budget towards salaries and wages)*

Projects that demonstrate additional cash or in-kind support—such as venue hire, materials, or staff time — will be highly valued.

**Inspiring WA invites budgets that demonstrate clear value for money. If your budget exceeds the suggested amounts for catering or wages but can justify the additional expenses, we encourage you to submit it.*

Successful Applicants

If your application is successful, you must:

- Sign a **grant agreement** outlining key requirements.
- Submit **photos** from the event to Inspiring WA and provide photo consent forms.
- Collect and submit **participant feedback** (survey templates provided).
- Complete a **final report** by 25 September 2026.
- **Notify Inspiring WA within 10 business days** of becoming aware of any major changes to your event.
- **Return funds** within one month if the event cannot proceed.

Failure to meet reporting requirements may impact eligibility for future grants.

Additionally, successful grant recipients will be asked to provide the following:

- **Project Summary for Website** – Provide a 150-word summary of your project for the Inspiring WA website once notified of your successful application.
- **Presentation Session** – You will be invited to a virtual session to present your project. Attendance is optional but recommended for first-time recipients.

Inspiring WA reports all grant activities to the National Inspiring Australia Network and the Commonwealth Government Department of Industry, Science and Resources (DISR), who funds the program. These requirements help demonstrate the impact of National Science Week and ensure continued support for science engagement.
